

End User License Agreement (EULA)

END-USER LICENSE AGREEMENT FOR THE FONT SOFTWARE. IMPORTANT: PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE INSTALLING: The End User License Agreement (“EULA”) of Marcus Sterz’ foundry FaceType (further on called “FaceType”) is a legal agreement between you (either an individual or a single entity) and FaceType for the FaceType font Font Software(s) identified above which may include associated software components, media, printed materials, and “online” or electronic documentation. By installing, copying, or otherwise using the Font Software, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and FaceType, (referred to as “licenser”), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the Font Software.

The Font Software is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Font Software is licensed, not sold.

1. GRANT OF LICENSE.

1a. Installation and Use.

FaceType grants you the right to install and use copies of the Font Software on your computer or workstation running a validly licensed copy of the operating system for which the Font Software was designed [e.g., Windows 95, Windows NT, Windows 98, Windows 2000, Windows 2003, Windows XP, Windows ME, Windows Vista, Mac OSX, etc.].

1b. Backup Copies.

You may also make copies of the Font Software as may be necessary for backup and archival purposes.

1c. Electronic Publishing/PDFs.

Embedding of the font software into electronic documents (i. e. PDF or Flash files) or internet pages is permitted only in a secured read-only mode. You must ensure that recipients of these documents or pages cannot extract the font software.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

2a. Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the Font Software.

2b. Distribution.

You may not distribute registered copies of the Font Software to third parties. Evaluation versions available for download from FaceType’s websites may be freely distributed.

2c. Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble the Font Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

2d. Rental.

You may not rent, lease, or lend the Font Software.

2e. Support Services.

FaceType may provide you with support services related to the Font Software (“Support Services”). Any supplemental software code provided to you as part of the Support Services shall be considered part of the Font Software and subject to the terms and conditions of this EULA.

2f. Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the Font Software.

3. TERMINATION

Without prejudice to any other rights, FaceType may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the Font Software in your possession.

4. COPYRIGHT

All title, including but not limited to copyrights, in and to the Font Software and any copies thereof are owned by FaceType or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of the Font Software is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by FaceType.

5. NO WARRANTIES

FaceType expressly disclaims any warranty for the Font Software. The Font Software is provided 'As Is' without any express or implied warranty of any kind, including but not limited to any warranties of merchantability, noninfringement, or fitness of a particular purpose. FaceType does not warrant or assume responsibility for the accuracy or completeness of any information, text, graphics, links or other items contained within the Font Software. FaceType makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb, or other such computer program. FaceType further expressly disclaims any warranty or representation to Authorized Users or to any third party.

6. LIMITATION OF LIABILITY

In no event shall FaceType be liable for any damages (including, without limitation, lost profits, business interruption, or lost information) rising out of 'Authorized Users' use of or inability to use the Font Software, even if FaceType has been advised of the possibility of such damages.
